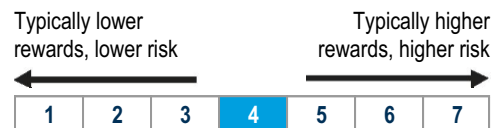

**Commentary and Outlook**

Gross of fees, the fund rose over the quarter, outperforming its composite benchmark.

Security selection accounted for almost all of the relative outperformance, chiefly owing to selections within the Japan equity portfolio.

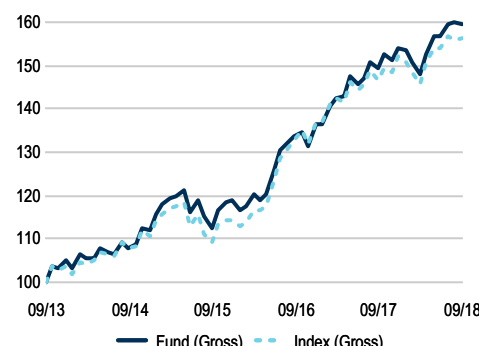
Within the underlying Threadneedle Japan Fund, baby and childcare product manufacturer Pigeon was the top performer. Sony also outperformed, on the back of strong growth in its Game & Network Services unit, and investors welcomed news that the company was developing a next-generation console.

Asset allocation was neutral, with detraction from our overweight global equities position offset by gains from the underweight in UK government debt.

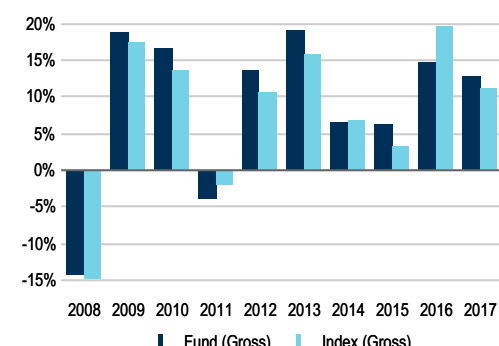
**Fund Objective & Policy**

To invest primarily in a portfolio of funds managed by Threadneedle. The portfolio will include exposure to equities and fixed income, and may include some exposure to other asset classes such as commodities, UK property and absolute return funds. The aim is to achieve total returns (from income and capital appreciation) that are above the composite equity, fixed income and property benchmark, gross of fees, over rolling 3 year periods.
